TERMS AND CONDITIONS

The undersigned acknowledges that he/she is the family designated on the reverse side and has full authority to enroll, sign for and act for the family. The undersigned further certifies that he/she as well as all family members coming to camp are physically, emotionally and mentally healthy and that the information contained in this application is true and accurate.

Each applicant must provide Camp Lindenmere Family, hereinafter called Camp, with a completed enrollment form signed and authorizing full payment. No allowance or reduction in the tuition will be given for late arrival or early withdrawal. No assignment of this contract by either party shall be valid or binding on the other unless the assignment is in writing and approved by written consent of the camp.

This agreement shall be deemed to have been made in Monroe County, Pennsylvania, regardless of the order in which the signatures have been affixed and shall be interpreted and the rights and liabilities of the parties determined in accordance with the laws of the State of Pennsylvania. All matters sounding in contract or in fact relating to the validity, construction, interpretation and enforcement of the contract will be determined in Monroe County, Pennsylvania. If any provision of this agreement is deemed to be illegal, unconstitutional or otherwise invalid, the remainder of the agreement shall not be affected but it shall be construed as if not containing the provision held to be invalid. In the event that any suit or proceedings is brought, the prevailing party shall be entitled to receive attorney fees, court costs and related expenses from the other party.

Camp will not be providing any medical staff during this event. Parents have full authority and control for the health, safety, and care for themselves, family and their child(ren).

The camp is not responsible for damage or loss of electronics, musical instruments, clothing or any other personal items or personal equipment whatsoever used during the family's stay. The camp specifically advises families not to bring jewelry or other valuables to camp.

During the camp session, families agree to abide by all camp rules and regulations governing health, safety and welfare of the families and the camp community. Including but not limited to, (a) the possession or use of weapons, narcotics or other intoxicants or nonprescription drugs is expressly prohibited both on and off the camp premises. Violations of these rules or other reasonable regulation may result in the dismissal from the camp without tuition refund. The camp has the sole discretion for any reason it deems appropriate to dismiss any family whose conduct is unsatisfactory or inimical to the camp and the camp community's best interests without any tuition refund.

This contract shall become binding when signed by an authorized agent of Camp Lindenmere Summer Camp, without delivery of a copy thereof to the undersigned applicant. If Camp is unable to perform any of its obligations under this contract by reason of governmental prohibition, fire, strike or damage by the elements, or of any unavoidable casualty, the obligations on its part will terminate at once. This contract contains all of the terms and conditions agreed upon by the parties and no other agreement, oral or otherwise, regarding the subject matter of this contract, shall be deemed to exist or to bind any of the parties.

The undersigned understands that exposure to the disease-causing organisms and objects, such as COVID-19, and personal contact with others, including but not limited to Camp Lindenmere employees, participants, and other associated with our programming and daily business, involves a certain degree of risk that could result in illness, disability, or death. The undersigned acknowledges all of this for the entire family and that it is impossible to screen and/or monitor all such individuals. All parties will follow recommended guidelines, social distancing when at all possible and if knowingly have been exposed prior to camp choose not to attend.
